### 1. Sites covered by this Policy Statement

# 2. Types of information we collect

This Privacy Statement covers personal information, non-personal data collection and aggregate reporting.

**Personal information** is information that is associated with your name or personal identity. Raes Training & Consulting uses personal information to understand better your needs and interests and to provide you with better service. Once you choose to provide us with personal information, you can be assured it will be used only to support your customer relationship with Rae's Training & Consulting. We take seriously the trust you place in us. Rae's Training & Consulting will not sell, rent or lease your personal information to others.
